We appreciate your interest in our annual Christmas Plus Bazaar.

Basic Information:

- The Christmas Plus Bazaar is held at Prairie Wind Middle School and Heart of the Lakes Elementary, Perham, MN. It is the biggest fundraiser for our swim club. LAPS is a not-for-profit organization dedicated to the development of good sportsmanship, self-discipline, team participation, physical ability, and the sport of swimming.
- **Booth Cost: \$70 each**
All booth sizes are 8 feet deep by 10 feet wide
- **Tables and chairs are NOT provided.**
- **Please take all boxes and extra garbage with you when you leave on Saturday. If we find garbage left a spot will not be guaranteed the following year.**
- We will have volunteers on hand to help you bring in and take out your merchandise.
- Note new show time!
- Set-up can be done between 5:00 PM - 8:00 PM on Friday and/or Saturday morning from 6:30 AM - 9:00 AM.
- Please note that school is in session on Friday, be respectful of the school pickup routine and bus spaces. We are not given access to the gyms to mark out vendor spaces until school is finished. There is no promise of early entry.
- Out of respect for our visitors and other vendors, there should be **NO EARLY TAKEDOWNS**. We will monitor the booths and if vendors takedown or vacate before 3:00 pm, a spot will not be guaranteed the following year.
- Vendor parking and trailer storage during the bazaar will be in the **Perham High School parking lot** or along the **playground by the HOTL elementary school**. We want as much close parking free to encourage shoppers to come.

- If the Bazaar must be canceled for reasons beyond our control, fees will be refunded. If this happens and you would still like to donate to our club, we would appreciate it.

If you cancel 2 weeks or less before the bazaar we will keep a \$50 deposit.

If you cancel 24 hours or less before the bazaar no refund will be given.

If you have been with us in the past, you do not need to send pictures. If you have not been with us in the past, we require pictures or a Facebook or the items you plan to sell along with your reservation form. We try our best to have a variety of booths in our show.

Acceptance letters will be emailed to you after September 1. Your canceled check will serve as the receipt of acceptance into the show. PENALTY — Operators who do not have Form ST19 or a similar written document from sellers can be fined a penalty of \$100 for each seller that is not in compliance for each day of the selling event.

Information for Sellers and Event Operators

Operators/organizers of craft, antique, coin, stamp or comic book shows; flea markets; convention exhibit areas; or similar events are required by Minnesota law to get written evidence that persons who do business at the show or event have a valid Minnesota tax ID number.

If a seller is not required to have a Minnesota tax ID number, the seller must give the operator a written statement that items offered for sale are not subject to sales tax.

All operators (including operators of community sponsored events and nonprofit organizations) must obtain written evidence from sellers.

Certain individual sellers are not required to register to collect sales tax if they qualify for the isolated and occasional sales exemption. To qualify, all the following conditions must be met:

- The seller participates in only one event per calendar year that lasts no more than three days;
- The seller makes sales of \$500 or less during the calendar year; and
- The seller provides a written statement to that effect, and includes the seller's name, address and telephone number.

This isolated and occasional sales provision applies to individuals only. It does not apply to businesses.
